**Safety Tips:**

**\*\*\*Indiana University has a zero tolerance policy for violence, crime or any other act that puts students in potential danger. (Code of Student Rights, Responsibilities, & Conduct and IU's Sexual Misconduct Policy)**

**The victim of a crime is never at fault. Here are some general tips to promote a safer campus:**

- **Speak up or call authorities** if you see someone who could be in trouble. Under Indiana's Lifeline Law, people younger than 21 who are under the influence of alcohol will not be prosecuted for crimes such as possession, intoxication or consumption of alcohol if they call 911 for medical help for another person or in cases of sexual assault and cooperate with police.
- **Remember: alcohol and drugs can impair perceptions of and reactions to situations. Therefore, someone who is under the influence cannot give consent by IU's definition.**
  - If you aren't sure you have consent, remove yourself from the situation and don't engage in sexual activity.
- **It's On Us to create a safe, supportive, and inclusive IU community.** Helping in potentially harmful incidents is part of that responsibility.
  - If you think someone is in danger, don't be afraid to take action or intervene.
  - For example, interrupting the situation without directly confronting someone by causing a distraction may prevent a potential danger.
  - If you are unable to step up, ask other people for help.
