## **Additional Budget Questions:**

Question about budget and Gala expenses. It was confirmed we will not do Gala this year. Concern brought up that budget is heavy toward community building; however, community building is more than social events. It also includes Welcome Week, Grad Student Engagement Week, and engaging graduate students. Concerns were brought that there is not enough detail in the budget for how the money will be used. It was clarified that advocacy funds are used toward special events, not the meetings themselves. The advocacy funds go to engagement with other students.

A breakdown of staff expenditures was also brought up. Adrian clarified that these are set by the university. The staff is three Student Academic Appointees: Community Development, Communications, and GPSG President. For the President, his position includes interacting with the Board of Trustees, Bloomington Faculty Council, and other administrators and committees. They correspond to the same amount of work as other Graduate Assistant positions in the

university. It was brought up that it would be beneficial to get statistics for the benefits brought by the expenses of GPSG, and that the transparency should be more effective.

It was also brought up why staff don't have committees. It is because they don't work with policies as much, but are happy to communicate with students.

A motion was brought forward to delay the vote on the budget until students have been able to view a more detailed budget. GPSG is constitutionally obligated to vote on the budget in October to fund our activities, which we still did.

A vote was brought forward to bring the budget back to the floor. It did have quarum.

A motion was brought forward to table the budget until next meeting. The Constitution/Bylaws say it must be confirmed at the next assembly meeting, so we must have another October Assembly meeting. Correction: the GPSG General Assembly will vote on the budget again at the General Assembly meeting on Friday, November 1<sup>st</sup>.
